



Entry requirements for a public school running an international education programme

Children may enrol in the International School programme until the application deadline in the following order of priority:

1. The children of foreign diplomatic, economic and other representatives may enrol in the International School programme if they provide evidence of this with the relevant documents. Children may enrol in the international school programme based on a valid passport, a certificate from the school attended by the child in the last year before enrolment and other relevant documents showing that the child's parents are foreign nationals working in the Republic of Slovenia.
2. The children of Slovenian diplomats who have lived abroad for at least two years and who can prove it with appropriate documents can enrol in the International School programme. Children may be enrolled in the international school programme based on a certificate from the school attended in the last year before enrolment and other relevant documents showing that the child has lived abroad with his/her parents.
3. Exceptionally, children of Slovenian citizens who have lived abroad for the past four years and who provide evidence of this with appropriate documents, and after examination of the application can prove that it is more beneficial to a child attending a school with an international programme to facilitate their adjustment to the national school system, are also allowed to enrol. Children may be enrolled in an international school programme based on a certificate from the school attended in the last year before enrolment and other relevant documents showing that the child has lived abroad with his/her parents.
4. If, after enrolment of children under the first three points, there are still enough vacancies in the department, other children of Slovenian and foreign nationals who, after examination of the application, are found more likely to benefit from attending a school with an international programme, due to their planned long-term departure abroad (stay, education), may exceptionally be allowed to enrol. Children may be enrolled in the international school programme based on appropriate documents showing that the child will be staying abroad, but no more than 2 years before departure abroad. The conditions are reviewed annually.
5. If there are still sufficient places available after the enrolment of children under the previous four points, other children of Slovenian and foreign nationals who, after examination of the application, state the reasons for enrolling the child in a school with an international programme, are found more likely to benefit from attending a school or kindergarten with an international programme, will exceptionally be allowed to enrol. The conditions are reviewed annually.



Pogoji za vpis v javno šolo, ki izvaja mednarodni program s področja vzgoje in izobraževanja

V program mednarodne šole se lahko do izteka prijavnega roka za vpis vpišejo otroci po naslednjem prednostnem vrstnem redu:

1. V program mednarodne šole se lahko vpišejo otroci tujih diplomatskih, gospodarskih in drugih predstavnikov, ki to dokazujejo z ustreznimi dokumenti. Otroci se lahko vpišejo v program mednarodne šole na podlagi veljavnega potnega lista, spričevala šole, ki jo je otrok obiskoval zadnje leto pred vpisom in drugih ustreznih dokumentov, iz katerih je razvidno, da so starši otroka tuji državljani, ki v Republiki Sloveniji opravljajo delo.
2. V program mednarodne šole se lahko vpišejo otroci slovenskih diplomatov, ki so vsaj dve leti bivali v tujini in to dokazujejo z ustreznimi dokumenti. Otroci se lahko vpišejo v program mednarodne šole na podlagi spričevala šole, ki jo je otrok obiskoval zadnje leto pred vpisom in drugih ustreznih dokumentov, iz katerih je razvidno, da je otrok s starši bival v tujini.
3. Izjemoma se vpis dovoli tudi otrokom slovenskih državljanov, ki so zadnja štiri leta bivali v tujini in to dokazujejo z ustreznimi dokumenti, za katere se po preučitvi vloge ugotovi, da je za otroka koristneje, da zaradi lažje prilagoditve na nacionalni šolski sistem obiskuje šolo z mednarodnim programom. Otroci se lahko vpišejo v program mednarodne šole na podlagi spričevala šole, ki jo je otrok obiskoval zadnje leto pred vpisom in drugih ustreznih dokumentov, iz katerih je razvidno, da je otrok s starši bival v tujini.
4. V primeru, da je po vpisu otrok po prvih treh alinejah še dovolj prostih mest v oddelku, se izjemoma dovoli vpis tudi drugim otrokom slovenskih in tujih državljanov, za katere se po preučitvi vloge ugotovi, da je za otroka koristneje, da obiskuje šolo z mednarodnim programom, in sicer zaradi načrtovanega dolgoročnega odhoda v tujino (bivanje, šolanje). Otroci se lahko vpišejo v program mednarodne šole na podlagi ustreznih dokumentov, iz katerih je razvidno, da bo otrok bival v tujini, vendar največ 2 leti pred odhodom v tujino. Pogoji se preverjajo vsako leto.
5. V primeru, da je po vpisu otrok po prvih štirih točkah še dovolj prostih mest, se izjemoma dovoli vpis tudi drugim otrokom slovenskih in tujih državljanov, za katere se po preučitvi vloge, v kateri so navedeni razlogi za vključitev otroka v šolo z mednarodnim programom, ugotovi, da je za otroka koristneje, da obiskuje šolo oz. vrtec z mednarodnim programom. Pogoji se preverjajo vsako leto.
